TERMS & CONDITION

1. Printed fee structure & mode of payment are given separately to the candidate. You can also download the fee structure from our website: - www.redwingsbpl.in
2. Candidate has to bear the cost of lodging, boarding and traveling to the site of practical maintenance facilities or OEPT. The candidates will be provided complete assistance before & during their stay at such facilities.
3. Tuition fee has to be paid by 10th of every month. GST and other taxes (if Applicable) should be paid in addition to the fees as mentioned above as per prevailing Govt. norms.
4. The student should submit the prescribed application form duly filled in along with the institution fees. Once a candidate is admitted to the institute, the fee is neither refundable nor transferable to any other account. All reasons shown for refund or transfer will be turned down.
5. Caution money is however refundable at the end of the completion of course. Damages of any sort are liable to be deducted from caution money.
6. All the examination fees either DGCA module or university semester exam will be paid by the candidates. However, this kind of fees will be nominal as per the rules of the concerned educational institution.
7. The student may be asked to produce the receipts of the fees paid by them, as when required. Hence, He/ She must preserve the receipts with Him /Her.
8. The fee will be accepted by DD/Online mode payment drawn in favor of Redwings Aerotechnique Pvt. Ltd. payable at Bhopal.
9. All students are required to remit their fees on or before 10th of every month. The defaulter will be charged Rs 100 per day as fine & will not be allowed to attend the classes if not paid within 1 month of due date & the name will be struck off from the roll.
10. Candidate from foreign countries should comply with the rules laid down by the concerned body/ council & the rules laid down by Govt. of India applicable to foreign students.
11. University tuition fee will be paid by the student to university authorities.
12. Candidates have to pay type rating course fee extra for cat.B1.1/B2.

16. FEE REFUND POLICY:

The joining fee & other fee paid by the student is spent on the institute for providing better facilities to the students and also for high quality education. Hence no refund of fee is permissible once a candidate has been admitted to the institute. The fee and the other charges once paid will under no circumstances be refundable, transferable or adjusted even if a student does not attend a single class. Students discontinuing in the middle of the course will forfeit the fee, other charges as security deposit.

17. The registration fee (seat booking) paid by the candidate is non-refundable. However, if the candidate is not eligible for this course—such as failing in 12th/Diploma or being medically unfit—30% of the fee will be deducted, and the remaining amount will be refundable within 30 days from the date of application.
